

MINUTES FOR TOWN MEETING

TOWN OF SABATTUS

May 14, 2015

AND ACTIONS TAKEN ON WARRANT FOR ANNUAL TOWN MEETING

Before the meeting started, State Representative Stephen Wood gave a brief update on what is happening in Augusta.

The Town Manager, Andrew Gilmore dedicated this year's Town Meeting to Alcide Castonguay who recently passed away.

Town Clerk, Suzanne Adams opened the meeting at 6:11 p.m. and read the following:

State of Maine

{To: Police Chief Anthony Ward, a Constable of the Town of Sabattus, County of Androscoggin, State of Maine}

GREETINGS:

In the name of the State of Maine you are hereby required to notify and warn the voters of the Town of Sabattus, in said county, qualified by law to vote in Town affairs to meet at the Sabattus Community Room at 190 Middle Road in said Town, on Thursday May 14, 2015, at 6:00 o'clock in the evening, then and there to act on the following articles:

ARTICLE 1. To choose a moderator by written ballot to preside at said meeting.

Action Taken on Article 1: Mark Duquette nominated Normand LaPlante as moderator of the Town Meeting. André Marquis seconded the nomination. Ballots were casts. Residents Connie Castonguay and Loretta Hinkley volunteered to count the ballots. Normand LaPlante is elected moderator and sworn in by Suzanne Adams, Town Clerk.

The moderator requested to allow the use of Robert's Rules.

The moderator requested a vote to allow the following non-residents to speak: Suzanne Adams, Town Clerk, Andrew Gilmore, Town Manager, Senator Garrett Mason, Representative Steve Wood, Anthony Ward, Chief of Police, Mark Veilleux, Fire Chief, Jerry Sabins, Transfer Station Manager, Paul Morin, Sabattus Water District and Alex Wong, Maine Rural Water.

Motion made by Ronda Fournier and seconded by André Marquis to allow non-residents to speak.

Vote Taken. It Passes.

ARTICLE 2. To see if the Town, in accordance with 36 M.R.S.A. Section 505(1), will vote that the tax lists specified in 36 M.R.S.A. Section 709 be committed for collection on or before September 1, 2015.
