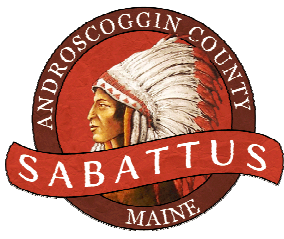
Treasurer's Report
