C: **Route 132 Project:** Town Manager is seeking feedback or guidance on the MeDOT highway rehabilitation plans for this project.

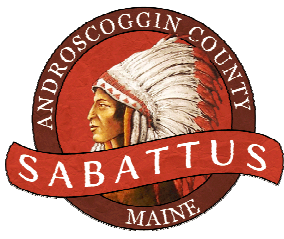
