The American Legion has requested a new special amusement permit that allows for game of chance. They would like to expand their fund raising by holding Texas Hold em games.

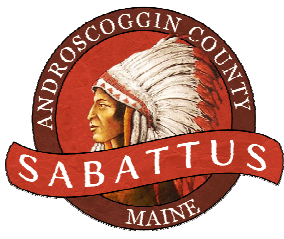
B: **Road Maintenance:** Town Manager is seeking guidance on amount of funding the Board wants in FY19 for roadway projects.
