New Business:

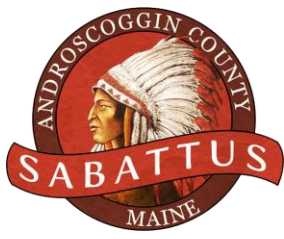
