ALL APPLICATIONS FOR A PERMIT SHALL BE ACCOMPANIED BY A PLOT PLAN SHOWING ACTUAL DIMENSIONS / DISTANCES AND ALSO SHOWING:

1. THE ACTUAL SHAPE AND DIMENSIONS OF THE LOT FOR WHICH THE PERMIT IS SOUGHT.
2. THE LOCATION AND SIZE OF ALL EXISTING BUILDINGS, STRUCTURES, WATER BODIES, AND OTHER SIGNIFICANT FEATURES CURRENTLY ON THE LOT.
3. THE EXISTING AND INTENDED USE OF EACH BUILDING OR STRUCTURE.
4. THE TYPE OF FOUNDATION

IT SHALL BE THE RESPONSIBILITY OF THE PERMIT HOLDER OR THE PERMIT HOLDER'S REPRESENTATIVE TO NOTIFY THE BUILDING OFFICIAL WHEN READY FOR INSPECTIONS AT EACH REQUIRED LEVEL.

A MINIMUM 24 HOURS NOTICE IS REQUIRED FOR ALL INSPECTION REQUESTS.

I hereby certify that I have read and examined this document and know the same to be true and correct. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. I further certify that I am the owner or the owner's authorized agent and that the proposed work is authorized by the owner. I understand that this application is not a permit to begin work and work shall not begin until the permit is issued by the building official, that I am responsible for calling for all required inspections, that work shall be accessible for inspections, that a final inspection, approval and Certificate of Occupancy is required prior to occupying this building. Fees are non-refundable. This permit application is only for the work described above. Every permit issued shall become invalid unless the work authorized by such permit is commenced within 180 days after its issuance, or if the work authorized by such permit is suspended or abandoned for a period of 180 days after the time the work is commenced.
