- 1. THE ACTUAL SHAPE AND DIMENSIONS OF THE LOT FOR WHICH THE PERMIT IS SOUGHT.
- 2. THE LOCATION AND SIZE OF ALL EXISTING BUILDINGS, STRUCTURES, WATER BODIES, AND OTHER SIGNIFICANT FEATURES CURRENTLY ON THE LOT.
- 3. THE EXISTING AND INTENDED USE OF EACH BUILDING OR STRUCTURE.
- 4. THE TYPE OF FOUNDATION

IT SHALL BE THE **RESPONSIBILITY OF THE PERMIT HOLDER OR THE PERMIT HOLDER'S REPRESENTATIVE**TO NOTIFY THE BUILDING OFFICIAL WHEN READY FOR INSPECTIONS AT EACH REQUIRED LEVEL.

A $\underline{\textbf{MINIMUM 24 HOURS NOTICE}}$ IS REQUIRED FOR ALL INSPECTION REQUESTS.

I hereby certify that I have read and examined this document and know the same to be true and correct. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. Fees are non-refundable. This permit application is only for the work described above. Every permit issued shall become invalid unless the work authorized by such permit is commenced within 180 days after its issuance, or if the work authorized by such permit is suspended or abandoned for a period of 180 days after the time the work is commenced.
